PARENTS PLEASE NOTE

- We discourage the payment through Cheque. If the cheque gets dishououred due to any reason a minimum penalty of ₹ 1000/ (one thousand rupees) will be charged.
- You may transfer the fee through NEFT, UPI or IMPS
- If you remit the fee thorough NEFT, UPI, IMPS, CBS, kindly submit the school fee challan (school copy) for our records.
- You are requested to preserve the details of fee remittance in digital form or hard copy for any further verification.
- Whenever you visit the school for any reason you are requested to carry the fee booklet.
- Please make sure you remit the fee at the prescribed bank account only. We do have two separate bank accounts for Sunari Wing and Shastripuram Wing.
- If anyone would like to pay the fee monthly contact the school office and get the provision of the same. In that case 15th date of every month is the last date to submit the fee without late fee charges. A late fee fine of ₹ 100/- per month will becharged after that for each passing month.
- Those who remit the fee through SCHOOL APP/WEB SITE (LOFTY PARENTAL PORTAL) will receive the online payment gateway charges as Discount.

IMPORTANT INSTRUCTIONS

1. School fees are to be paid for full year, i.e. for all twelve months.
2. The fee is to be submitted quarterly. The last date to pay the fee is mentioned in the respective slips.
3. The fee for the current Quarter (3 months) should be paid together at once.
4. All Fees to be remitted at the SCHOOL ONLINE PAYMENT PORTAL or at Canara Bank, Shastripuram branch.
5. No fee transaction will be accepted in the school either as cash or cheque.
6. You can also submit the cheque at Canara Bank, Shastripuram branch, along with the fee paying slip.
7. In case the cheque gets dishonoured due to any reason a penalty of minimum ₹ 1000/ (one thousand) will be charged.
8. Fee once paid are not refundable in any case. (please do pay the exact amount that is detailed in the fee paying slip)
9. The paying-in slips should be correctly filled in by the parents/guardians and counter foil must be retained for further verification and proof.
10. Fees of the current quarter to be paid in the first month of the quarter after which a late fee charged of ₹ 300/- per month will be charged. (₹ 300/- for each delayed month).
11. Those who remit the total fee of the academic year one time only through SCHOOL APP/ WEBSITE (LOFTY PARENTAL PORTAL) before 10th May, 2022 will get ₹ 1000/- as rebate.
12. If any mistake is committed in filling the fee slip, resulting in wrong posting of the fees, the school management will not be responsible for the resultant inconveniences.
13. The scholar whose fees fall in arrears is liable to be debarred from attending school and taking the exam, till the full fees are paid.
14. A duplicate fee booklet will be issued on payment of ₹ 50/- only.
15. There will be proportionate increment in the fees every year as per the UP Self-financed independent school (Fee Regulatory) Act 2018.
16. Annual composite fee is an all-inclusive fee except exam fee. Calculated and approved by the UP Self-financed independent school Fee Regulatory Authorities.
